Unlike most coverage lawyers who have represented clients on only one side of the industry, Chris began his career defending multinational insurance carriers. - A multinational drilling company in a putative class action filed in New York federal court alleging environmental groundwater contamination;

While he spends much of his time litigating, arbitrating and mediating complex insurance coverage disputes, Chris is acutely aware that an ounce of counseling "prevention" is worth a pound of litigation "cure." With that in mind, he works with corporate policyholders and their insurance brokers during the policy purchase and renewal stages to understand and anticipate applicable risks and to negotiate the best insurance policy language available.
